Still No Legal Standing for Unsuccessful Bidder – In *Byrne and Jones Enterprises, Inc. D/B/A/ Byrne and Jones Construction, v. Monroe City R-1 School District*, ED101588 (November 12, 2014) the Eastern District Court of Appeals issued a strong opinion again confirming that competitive bidding statutes are for “the benefit of the public only” and rejection of a bid “creates no vested interest or property right in the rejected bidder.” The court, therefore, dismissed for lack of standing the losing bidder’s suit seeking to enjoin the school from entering into a construction contract with the winning bidder. The Court also rejected the losing bidder’s request for his bid-preparation costs because awarding such costs “would thus only add to the public’s cost for the project... [and] runs completely counter to the purpose and underlying policy of the bidding statutes.”

New FCC Rule on Wireless Facilities – The Federal Communications Commission (“FCC”) released a “Wireless Infrastructure Order,” setting forth new rules regarding wireless facilities, including how cities can review such facilities. While the order preserves public safety laws, cities may need to reevaluate their procedures as this continues to limit municipal authority. See [FCC Rule 14-153](#).

Updated Best Practices for Investment of Bond Proceeds Released by GFOA – The Government Finance Officers Association (GFOA) has provided updated best practices for investment of bond proceeds with specific recommendations on how to engage investment brokers. The updated best practices take into account the new rules that have recently been released by the SEC to govern the practices of municipal financial advisors. Under the new SEC rule, to act as a municipal advisor, a person or firm must be registered with the SEC. If a municipality chooses to hire a municipal advisor, that municipal advisor owes a fiduciary duty to the municipality and can provide specific investment advice. On the other hand, those underwriters or other professionals that are not registered municipal advisors do not owe a fiduciary duty to municipalities and therefore generally cannot provide specific investment advice to the governmental entity (unless some limited exemptions are met). GFOA’s Best Practices on Investment of Bond Proceeds recommends that governments “have in place policies and procedures for when they will engage the use of an investment adviser or municipal advisor.” In addition, municipalities that do not have specific staff tasked with monitoring markets and their investments “are strongly encouraged to use a municipal advisor or investment adviser.” For questions please contact [Kim Diamond](#) or [Kristen Erickson](#).

Best Practice Reminders for Collateralization of Public Deposits – Missouri law is clear that banks must pledge securities to collateralize all public deposits to the extent the deposit is not covered by FDIC insurance. Less clear, however, is what type of legal interest the city must have in pledged securities. [Section 110.010.2](#) RSMo. allows a party other than the city to hold securities as collateral for city deposits. Under this law, there are only two permissible options when a third party holds securities as collateral for the city: 1. A bank holds securities in the city’s name, or 2. A trustee holds securities in the city’s name. In both options, the city’s name must be on the securities, including on uncertificated securities. A few basic best practices to remember include:

1. Have a policy requiring contracts with all financial institutions. Such contracts will help ensure that the city complies with and can enforce Missouri laws securing the deposit of public funds.
2. Select a bank or trustee that has an office in Missouri. This will make enforcement easier if the city must take legal action to liquidate securities held as collateral.
3. Collateral securities may *not* be held in a brokerage account, even if the account is titled in the city’s name.

No Court Filing Fee for Government Attorneys Using E-Filing – As more Missouri courts implement electronic filing for court documents, cities should be aware that government attorneys are now exempt from filing fees on new cases when using e-filing. [Court Operating Rule 27.02\(b\)](#) defines a “government attorney” as one who is using the e-filing system in his or her capacity “as a lawyer for the state of Missouri or one of its political subdivisions.”

Upcoming Dates & Deadlines for Missouri Municipalities*

Dec. 16 – Opening of candidate filing period for Municipal General Election.

Jan. 1 – Furnish State Auditor report of bonds and coupons retired since the previous report.

Jan. 20 – End of candidate filing for Municipal General Election.

Jan. 27 – Closing for receiving certification of election forms for the General Municipal Election.

Jan. 31 – File report with DED on previous year’s revenue bond and general obligation bond issuances for Industrial Development Projects.

Jan. 31 – Send W-2s and 1099s to IRS; distribute to employees and service providers.

Feb. 28 – Report to DOR businesses that have relocated within past year to TIF area or Downtown and Rural Economic Stimulus Act development area.

Mar. 5 – Notify DOR of ordinance opting-in to “Show Me Green” Appliance Sales Tax Holiday (at option of City).
